

Lacamas Community Credit Union
Debit Card Promotion 2009
OFFICIAL RULES

- 1) **Contest Sponsor:** Lacamas Community Credit Union
- 2) **Eligible Participants:** Current Members of Lacamas Community Credit Union who are 18 years of age or older; and who are U.S. Citizens or non-U.S. Citizens who pay U.S. taxes. Subject to paragraph 5 below.
- 3) **To Enter:** The contest begins June 1, 2009 and ends on August 31, 2009. Eligible Participants are automatically entered into the random drawing by making purchases with their LCCU Visa® debit card, one entry per purchase transaction. See paragraph 11 below for an available “no deposit necessary” exception.
- 4) **Drawing:** Lacamas Community Credit Union will conduct a random drawing to select contest winners on or about July 1, 2009, August 1, 2009, and September 1, 2009 from all eligible entries received between June 1, 2009 and August 31, 2009. Odds of winning are based upon number of entries. The credit union reserves the right to end the drawing at any time without notice or to make adjustments to the timing and amount of prize at any time without notice.
- 5) **Eligibility Exceptions and General Terms:** Employees and volunteer officials of Lacamas Community Credit Union and its affiliates, their immediate families (spouse, parents, children, siblings, and their spouses), and individuals living in the same household of each of the above are ineligible. Additionally, any member who has now or in the past defaulted under a Lacamas Community Credit Union agreement, or otherwise caused a loss to the credit union are also ineligible. Lacamas Community Credit Union organization and business accounts are ineligible. Contest void where prohibited or restricted by law. Federal, state, and local taxes are the sole responsibility of the prize winner. Contest is subject to all applicable federal, state (Washington), and local laws and regulations. No substitutions or transfers of prize permitted except at sole discretion of Lacamas Community Credit Union. Entrants also agree to the use of their name and photograph in any Lacamas Community Credit Union publication or website if chosen as a prize winner.

If a potential winner cannot be reached within seven (7) days from the first notification attempt, then such person shall be disqualified and an alternate winner will be selected. The prize winner may not transfer their prize to any other party prior to acceptance.
